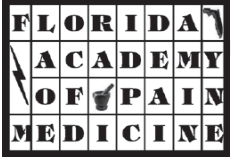

Friday, July 16, 2010 – Workshops

A. Basic Pain Medicine and Opioids Course – Ten Topics

1. Basics of Pain Science

Michael H Moskowitz MD MPH

At the end of this session, participants will be better able to distinguish chronic pain from acute pain; explain chronic pain within the context of the biopsychosocial model; discuss current knowledge about the pathophysiology of chronic nociceptive and neuropathic pain; distinguish between the symptoms of pain and the disease of pain.

2. Evaluation and Treatment Planning of Chronic Neuropathic and Musculoskeletal Pain

Marla D Golden DO MS

At the end of this session, participants will be better able to apply the principles of appropriate clinical assessment to patients with chronic pain; develop a clinical assessment and treatment plan using a biopsychosocial approach; employ the principles of multimodal treatment for patients with chronic pain.

3. Pharmacology of Pain: Opioids

Michael H Moskowitz MD MPH

At the end of this session, participants will be better able to determine the place of opioids in the complex rational polypharmacology used in the treatment of chronic pain; describe several different types of short and long acting opioid medications; develop treatment strategies for selecting, adjusting, and changing opioids in the treatment of chronic pain; explain the treatment strategy of using opioid tolerance to lower pain in chronic pain patients.

4. Pharmacology of Pain: Non-opioids

Albert L Ray MD

At the end of this session, participants will be better able to determine the place of non-opioid medications as part of the complex rational polypharmacology used in the treatment of chronic pain; describe several different types of non-opioid medications including SNRIs (serotonin-norepinephrine reuptake inhibitors), NSAIDs (nonsteroidal anti-inflammatory drugs) and AEDs (anti-epileptic drugs); explain the treatment strategy of using non-opioids to lower pain in chronic pain patients.

5. Pharmacology of Pain: Psychotropics

Albert L Ray MD

At the end of this session, participants will be better able to determine the place of psycho-pharmacological medications as part of the complex rational polypharmacology used in the treatment of chronic pain disorders; describe several different types of commonly used medications including SNRIs, SSRIs (selective serotonin reuptake inhibitors), anxiolytics, and hypnotics; develop treatment strategies for selecting, adjusting, and changing SNRIs, SSRIs, anxiolytics, and hypnotics in the treatment of chronic pain; explain the treatment strategy of using psychiatric medications to manage pain in chronic pain patients.

6. Abuse, Addiction, and Diversion

Marla D Golden DO MS

At the end of this session, participants will be better able to differentiate between abuse, addiction, tolerance, and dependency; discuss the classes of abused substances; discuss abuse as a medical issue and diversion as a legal issue; outline the different approaches to treating abusers and dealing with diverters.

7. Interventional Pain Techniques and Treatments

Dennis J Patin MD

At the end of this session, participants will be better able to place the role of interventional procedures in the continuum of pain management; list the various types of interventional procedures; discuss the indications for various procedures; state the efficacy and safety of selected procedures; refer appropriately for these procedures.

8. Non-interventional/Non-invasive Pain Techniques and Treatments

Marla D Golden DO MS

At the end of this session, participants will be better able to determine the place of non-invasive approaches in the treatment of chronic pain; list several different non-invasive approaches to treating chronic pain; develop strategies for selecting non-invasive approaches; evaluate appropriateness, efficacy, and outcome of non-invasive treatments for chronic pain.

9. Documentation and Safe Practices

Michael H Moskowitz MD MPH

At the end of this session, participants will be better able to explain how proper documentation provides access to treatment for patients with chronic pain disorders; protect their practices through proper documentation; access guidelines designed to help protect the public from diversion of controlled substances; use cumulative notes documenting successes and failures to provide more effective treatment planning.

10. The Difficult Patient

Michael H Moskowitz MD MPH

Marla D Golden DO MS

Albert L Ray MD

At the end of this session, participants will be better able to define the difficult patient and identify the elements of a difficult case; describe the usefulness of the biopsychosocial approach in the treatment of the difficult patient; review the difficult case from the perspectives of the patient, physician, disease, and the system; recognize their own limitations in treating some patients, and make appropriate referrals for improved outcomes.

B. Ultrasound Workshop: Platelet Rich Plasma (PRP) Injections with Ultrasound Guidance and Patient Demonstrations

Thomas Clark DC RVT

Felix S Linetsky MD

At the end of this session, participants will be better able to outline the principles of ultrasound imaging and guidance; perform needling techniques for the shoulder, elbow, wrist, spine, pelvis, and lower extremities; inject PRP into these structures.

Saturday, July 17, 2010

Morning Theme: The Brain, the Body, and Pain Syndromes

The Neuroplastic Brain: Pain and Pleasure

Michael H Moskowitz MD MPH

At the end of this session, participants will be better able to outline several pain theories as they relate to the brain; describe changes in the brain that occur due to nociceptive and neuropathic pain; list several methods of changing the brain's neuroplastic altered state caused by persistent pain; discuss the symmetry of brain-based pain and pleasure circuits to return brain homeostasis for pain control.

Neuromodulation

Giancarlo Barolat MD

At the end of this session, participants will be better able to list the disciplines involved in neurostimulation including but not limited to neurology, cardiology, vascular surgery, cariology, pain management, neurophysiology, and psychiatry; manipulate the functions of the nervous system through surgically implanted technology to control the malfunction of various body systems; list the various neurostimulation modalities; list indications for neurostimulation.

Manual Therapies in the Treatment of Pain

Marla D Golden DO MS

At the end of this session, participants will be better able to list the types of manual therapies available; discern the optimal manual therapy for various patients; discuss the current basic research documenting and determining the utility of manual therapy with respect to soft tissue injury; place manual therapy in the comprehensive pain management treatment plan.

Cognitive/Emotional Therapies for Neuroplastic Pain Syndromes

Albert L Ray MD

At the end of this session, participants will be better able to state the role cognitive-behavioral techniques can serve in helping patients minimize the impact of pain on their functional status, ability to think, emotions, and pain perception; identify four types of cognitive-behavioral therapies; instruct caretakers to utilize these approaches with a patient in pain; refer appropriately to retrain brain pathways on pain perception.

Peripheral Field and Peripheral Nerve Stimulation

Giancarlo Barolat MD

At the end of this session, participants will be better able to recite the history of peripheral nerve stimulation; identify the peripheral nerve roots, the large peripheral nerves, and the small subcutaneous nerve fibers; list peripheral nerve stimulation applications for pain; stimulate the peripheral nervous system for relief of pain.

Saturday, July 17, 2010

Afternoon Theme I: The Brain, the Body, and Pain Syndromes

Acupuncture in Pain Medicine

Di Fu MD (China), CA, FL Lic AP

At the end of this session, participants will be better able to discuss the history and development of acupuncture; describe the neurological mechanism of acupuncture; explain the Traditional Chinese Medicine (TCM) view of pain in terms of blockages in channels and collaterals and poor nourishment; explain the TCM treatment of pain in terms of regulating channels and collaterals and nourishing soft tissues; compare the value, efficacy, and efficiency of acupuncture pain treatment to western medical pain treatment.

Stem Cells in Pain Management

Christopher J Centeno MD

At the end of this session, participants will be better able to discuss the future of medicine as biologic, a shift from management to repair using adult mesenchymal stem cells (MSCs); list what MSCs have repaired to date; contrast and compare the safety of repair with MSCs vs surgical alternatives; debate fluoroscopy vs ultrasound use with MSC repairs; outline effects of radiographic contrast and anesthesia on cells; discuss stem cell manufacture and its regulation.

Medical, Rehabilitation, & Interventional Care: Sacral/Coccyx Injuries

Michael E Frey MD

At the end of this session, participants will be better able to list the risk factors for sacral insufficiency fractures (SIFs); recognize the signs and symptoms of SIFs; diagnose SIFs using physical examination and radiological technology; treat SIFs conservatively; discern when more aggressive treatment may be warranted; discuss percutaneous sacroplasty as an interventional therapy option; discuss a multi-center trial on the efficacy and safety of percutaneous sacroplasty for osteoporotic SIFs.

Regenerative Injection Therapies (RITs): Prolotherapy, Sclerotherapy, and Platelet Rich Plasma (PRP) in Pain Treatment

Felix S Linetsky MD

At the end of this session, participants will be better able to discuss the common mechanism of action that various injectates have when treating pain arising from connective tissue disorder; list current applications for RITs and discuss future possible applications; compare and contrast ultrasound vs fluoroscopy when guiding injection treatments; employ ultrasound guided injections for diagnosis of tendinopathies.

Prospective Interventional Pain Medicine Study – PRP Intradiscal Injection

Jack Miletic MD

At the end of this session, participants will be better able to discuss an ongoing prospective, randomized, controlled study investigating the utility of intradiscal platelet rich plasma (PRP) injections in patients with discogenic mediated low back pain as determined by discography.

How to Grow and Maintain an Outpatient Concussion Practice

Nathan D Zasler MD

At the end of this session, participants will be better able to medically direct an outpatient concussion clinic; examine potential staff and space requirements for an interdisciplinary concussion clinic; consider various options for concussion clinic assessments and treatments for improving patient care; discuss marketing strategies to improve/diversify patient referral base; compare the pros and cons of becoming involved in medicolegal work with cases involving concussion.

How to Grow and Maintain an Inpatient Rehabilitation Practice/Navigate IRF (Inpatient Rehabilitation Facility) Rules, Denials, and Inpatient Rehabilitation Requirements

Mitchell J Freed MD

At the end of this session, participants will be better able to access and discuss new policies for determining and documenting the medical necessity of an IRF admission; identify Criteria for IRF admissions to be Considered Reasonable and Necessary; document appropriately and adequately for IRF admissions; comply with CMS requirements regarding documentation rules for physician extenders and Residents.

How to Grow and Maintain an Independent Medical Evaluation Practice

Anthony J Dorto DC MD FAAPM&R FAADEP

At the end of this session, participants will be better able to prepare a complete, state-of-the-art independent medical evaluation, and when appropriate, perform a complete, state-of-the-art independent medical examination; list your IME practice in professional directories; educate your referral sources (case manager, attorney, insurance adjuster, etc) about your specialty; purchase evaluation instruments; avoid IME conflicts.

How to Grow and Maintain a Neurotoxin Practice

Carolyn Geis MD
